- > Sanitizer is readily available to all staff so cleaning can take place throughout the day.
- Equipment is cleaned and sanitized regularly.
- > Areas used by a sick person will be properly cleaned and disinfected.
- > Ventilation systems are regularly cleaned and serviced to ensure the cleanest air possible.
- > The District will monitor safety recommendations from the CDC and NJ Department of Health and make adjustments as necessary.

## E. Contact tracing in combination with isolation and quarantine, in collaboration with the State, local, territorial, or Tribal health departments.
