VII. SUPERINTENDENT'S REPORT

ARBOR STUDENTS TAKE A WALK THROUGH HISTORY

Fifth grade students at Arbor School took a step back into the Civil Rights Era during their Language Arts classes in recognition of Black History Month. During their 'Gallery Walk' students silently moved around the room, deep in thought, reviewing powerful images, videos and informational texts their teachers displayed on particular topics. The students wrote down comments and questions about each image. After completing the gallery walk, students reviewed others' comments and stood next to the photo that impacted them the most. Next, they created their own title and comments about that image. Students in Mrs. Laura Stoddard's class, after reviewing the story of Ruby Bridges, shared their thoughts about community and school diversity. One student stated, "We have the chance to meet new people and have conversations with them." Mrs. Stoddard noted that this concise statement shows, "We all have something wonderful to share."

PISCATAWAY NAMED TO AP HONOR ROLL

Piscataway was named to the College Board AP Honor Roll, one of only 39 high schools in New Jersey to achieve this milestone. Piscataway was named due to achieving the double distinction of building a significant increase in the number of students taking AP courses, while simultaneously increasing the number of students scoring a 3 or above on the AP exams. This could translate to significant college savings for these students, as scoring 3 or above may count for course credit at colleges and universities across the country. Well done, PHS students!

SCHOR STUDENTS VISIT MUSEUM OF MATHEMATICS

Schor students attended a field trip to New York City's Museum of Mathematics, an <u>award winning museum</u> that highlights the role of mathematics in illuminating the patterns and structures all around us. Students explored the museum's hands on exhibits and attended a Graph Theory workshop based on the Bridges of Konigsberg problem, considered to be the first theorem of <u>graph theory</u>. Students will be creating their own exhibits inspired by their trip to be displayed at Schor. The field trip was sponsored by an Inspire Grant from the Piscataway Education Foundation.

CAT IN THE HAT STACKS AT EISENHOWER

Eisenhower second grade math LEAP students celebrated Read Across America Week using the engineer design process! The students completed "Hat Stack," a STEM challenge inspired from the story "The Cat in the Hat." Students were challenged to create the tallest "hat stack" in ten minutes using only paper and cups. Using these materials and limitations, students planned, engineered, tested, and shared their "Hat Stacks."

PHS STUDENTS PLACE THIRD IN ETHICS DEBATE

Piscataway High School placed third in two separate groupings at the Stevens Institute Regional Ethics Debate Completion. A total of 18 teams participated. The High School Ethics Debate Competition introduces students to critical thinking about ethical issues in today's world. Piscataway has had teams place first, second, or third each of the last four years.

QUIBBLETOWN HOLDS SECOND ANNUAL CULTURAL EXTRAVAGANZA!

Quibbletown's Second Annual Cultural Extravaganza was a huge success, combining a pot luck dinner with student performances. Students contributed foods that "said something about who they are." The Cultural Celebration that followed included dances, singing, spoken word, Jazz Band and 8th Grade Choir performances. For the finale, all performers sang and played John Lennon's *Imagine*. The performances were repeated during the school day for the entire student body. Those assemblies included a presentation from Raices Cultural Center about their recent relief trip to Puerto Rico. Quibbletown PTG donated proceeds from the November Talent Show to Raices to help fund their trip.

PHS ACHIEVES AT TITAN BUSINESS SIMULATION

On Monday, February 5, 16 PHS teams went on to the final round of TITAN Business Simulation Competition. PHS's Team AKA (Adam Liang, Kunal Thakker, and Adam Nathoo) avenged last year's second place finish to win first place (\$1000), and team NHK (Neel Gandhi, Hammad Ghani, and Kenneth Narvaez) took 3rd place (\$250) at the NJ State Finals of the Junior Achievement TITAN competition today at Ethicon (a Johnson & Johnson Company).

GLOWFEST GLOW IN THE DARK FITNESS FUN AT KNOLLWOOD

On Friday, February 9, Knollwood Elementary held its annual PTO Glowfest. A total of 450 staff, students and parents engaged in a rigorous, yet fun night of fitness in the dark. B. RESOLUTION IN SUPPORT OF GUN CONTROL AND MENTAL HEALTH SERVICES TO PROTECT OUR YOUTH

WHEREAS, A prerequisite to student growth, learning, well-being and success is a safe and secure school environment; and

WHEREAS, Children throughout the nation have been negatively affected directly and indirectly by violent crimes involving firearms; and

WHEREAS, Military-style assault weapons and large-volume ammunition magazines were used in recent mass killings in schools and other locations; and

WHEREAS, Profiles of school shooters illustrate the need for a thorough examination of the care and treatment of the mentally ill and for effective intervention;

WHEREAS, The New Jersey School Boards Association's 2014 study, What Makes Schools Safe?, cited reports by state and federal agencies, which found that mental health intervention did not take place prior to three-quarters of school shootings; and

WHEREAS, New Jersey has among the strongest gun control laws in the nation and the lowest incidence of gun-related deaths, but protective laws are not in place in many other states or at the federal level; and

WHEREAS, The tragedies of Parkland, Florida, of Newtown, Connecticut, of Columbine High School in Colorado, emphasize the need to address access to firearms and the delivery of mental health services. Now, therefore, be it

RESOLVED, That the Piscataway Township Board of Education, in the County of Middlesex, State of New Jersey, urges President Trump and Congress to identify and implement meaningful action to address access to and ownership of military-style assault weapons and ammunition, the delivery of mental health services, and financial support to ensure a safe and secure school climate; and be it further

RESOLVED, That the Piscataway Township Board of Education supports Governor Murphy's call to end the "epidemic of gun violence that plagues far too many of our communities" and supports enhancements to state law that will provide protection for our schools and communities; and be it further

RESOLVED, That a copy of this resolution be sent to President Donald Trump, U.S. Senator Robert Menendez, U.S. Senator Cory Booker, U.S. Representative Frank Pallone, Governor Phil Murphy, State Senator Robert Smith, Assembly Representative Joseph Egan, Assembly Representative Joseph Danielsen, the Middlesex County Freeholders, the New Jersey School Boards Association, and the National School Boards Association.
