PHS/RUTGERS BIOMEDICAL PROGRAM OFFERS ADVANCED EDUCATIONAL OPPORTUNITIES AND COLLEGE CREDITS

Four years ago, Piscataway High School began its BioMedical Career Pathways Program in partnership with Rutgers University. This program introduces students interested in medical sciences to college-level learning and the opportunity to -- along with high school credits -- earn up to 14 Rutgers University credits. These credits can be applied to a Rutgers degree or to a Rutgers transcript to transfer to other colleges and universities. The Piscataway teachers involved in this program, Dr. John Murphy, Ms. Leslie Wilson, and Dr. Lisa Szeto, are all certified as Rutgers Adjunct Professors. We are very pleased to announce the program results for this year's graduating seniors: twenty-three seniors will graduate with fourteen credits; six seniors will graduate with seven credits; five seniors will graduate with three credits. This is a great example of how Piscataway Schools partners with the world-class university within our town and how we develop challenging curriculum within our high school. Congratulations to our students, teachers, and Science Department Chair, Ms. Gita Manchanda.

PHS FILM STUDENTS WIN AGAIN

PHS film students were recognized for more honors:

- "Aphonia" directed by Audrey Visscher was a finalist -- in the top 30 out of 180 in New Jersey -- and won first place for opening credit sequence in the Ten-Day Film Challenge.
- "Broken: The Musical," directed by Reese Garcia, won first place for music videos in the Creskill NJHS Film Festival.
- "Broken: Friends," directed by Jenna McKim, was a finalist in the NJHS Five-Day Film Challenge -- one of the top 20 out of 135 submitted films. Lea Rafisura, who won the prestigious best actress award for her role in this film.
- "Broken: Lockdown," directed by Danny Allen, was a finalist in the Five-Day Film Challenge.

MS. ROYSTON RELEASES NEW CD

Conackamack Music teacher Shamie Royston will launch *Beautiful Liar*, her second CD with her jazz trio, on June 20. Ms. Royston is an accomplished jazz pianist and composer who shares her passion for music with her students. She introduced Jazz Night at Conackamack two years ago and plans to bring additional new ideas in music to Conackamack and the district. Congratulations, Ms. Royston!

GATOR GREATNESS AT ARBOR

The Gator Greatness Showcase took place at Arbor School on May 22. Families took “gallery walks” and spoke with students who had projects on display in art, literature, technology, science, world language, and instrumental music. Student work included “Adventures of the Sea,” a themed art display, and several anti-bullying videos -- written, directed, and performed by students in the Technology Club. Readings featured selections from Arbor's *Fantastic 4 Literary Magazine*. Science Club experiments, Spanish Gifted and Talented students' research projects, and performances by the Orchestra, Band, and Hand Bell Choir rounded out the event.

EISENHOWER HERITAGE WEEK

Eisenhower celebrated its first Heritage Week with special presentations from Eisenhower moms who shared their beautiful cultures with the students. Presentations included Indian cultural dancing and an introduction to the Penobscot American Indian Nation, as well as a student fashion show and flamenco dancing. Throughout the week, students visited each other's classrooms and shared cultural research on a “passport tour.” Students embraced the diversity of Piscataway and the opportunity to learn from each other.

RANDOLPHVILLE STUDENTS INTERACT WITH SCRATCH

Randolphville students learned a new language – Scratch – in a fun, interactive workshop, Barclays Code Playground. Using Scratch, third graders applied their coding skills to create their own computer games. Students captured fish and sharks, and designed backgrounds within the program. Exposing elementary students to coding challenges such as this opens doors to further exploration of computer science as they advance through their studies.

ELL STUDENTS LEARN HISTORY

On June 5, Ms. Curry's ESL Jump Start class — which includes middle school English Language Learners from all three middle schools who come from Guatemala, India, Afghanistan, Colombia, Dominican Republic, Iraq, Korea, Ecuador, Pakistan, Egypt, Haiti, and Peru — enjoyed a class trip to Ellis Island and the Statue of Liberty. Thanks to planning by Ms. Husbands, the students learned first-hand about early US immigration and the history of the Statue of Liberty. It was an exciting and moving day for both the students and their chaperones, Ms. Husbands and Mr. West.

ROBOTICS COMES TO ARBOR AND KING

PHS students, their robotics team coordinators -- and their robots -- visited fourth grade students at Arbor and King. They assisted the younger students in building code and using controllers to complete tasks. The younger students learned of many opportunities available to them to get involved in robotics. Best of all, they learned how teamwork is the most important part!

KNOLLWOOD EXAMINES GOLDILOCKS

Third Grade Law Fair at Knollwood Elementary presented *The Trial of The Three Bears versus Goldilocks* as their mock trial. The performance chronicled events of the day when Goldilocks entered the Three Bears' house. Students worked diligently while learning about the criminal justice and court system, script development, role playing, and set design. They performed during the school day for teachers and peers, and the following evening for friends and family.

STEAM TEAM BRINGS TOY WARS TO SECOND GRADE STUDENTS

Supervisors and instructional coaches from STEAM fields across the district brought classic toys to each of the elementary schools. Elementary students played with view masters, Slinkys, Rubik's cubes, jacks, xylophones, and shape sorters, and were asked to engineer new designs to enhance the toys. The students offered many imaginative and creative ideas during this challenge.

AUTHOR ELIZABETH EULBERG VISITS GRANDVIEW

Grandview third grade students were excited to meet author Elizabeth Eulberg during her recent visit to the school. The students read and loved Eulberg's "The Great Shelby Holmes" series during their mystery unit in Readers Workshop. Meeting the author, hearing about her writing process, and having her answer their questions, enriched their reading experience. Mr. Ahrens and Mrs. MacMillan organized the visit.

TEACHERS PARTNER WITH FDU

Eleven Pway teachers continued their own education to help students overcome dyslexia. The teachers completed a three-credit graduate course at Fairleigh Dickenson University that provided both lecture and practicum experiences for the Orton Gillingham multi-sensory instructional approach to reading, writing and spelling. One of the primary instructor's was Grandview's Support Specialist Leslie Daise, an adjunct professor at FDU.

On Wednesday, May 30, five more student/athletes signed college admission commitments, bringing the total number for the year to twenty. KNOLLWOOD LEAP STUDENTS FOLLOW EDISON'S FOOTSTEPS

Knollwood's Grade 2 LEAP students took a trip to the Thomas Edison Memorial Tower and Museum in Edison, NJ. After researching Edison's life and inventions, students experienced "The Wizard of Menlo Park", his laboratory, inventions, experiments, and achievements. Students experimented themselves -- separating iron ore from sand, activating a human battery, turning on and off circuits, and cranking to generate force to power a light bulb.

PHS STUDENTS SCORE IN SCIENCE LEAGUE

PHS student Rishi Patel led Team PHS in Science League, scoring one-hundred-percent on every Chemistry test throughout the year. He was named number one in the state for Chemistry, while steering the team to a sixth place overall finish. Nick Chen also achieved outstanding results, ranking in the top fifteen percent in Chemistry. Other team results included Biology 1 Team: rank 49/124 teams; Biology 2 Team: rank 28/122 teams; and Physics C (AP Physics) Team: rank 36/73 teams. Congratulations to all PHS students who participated in this rigorous academic competition.

PHS STUDENTS BREAK KAHOOT

On Monday, May 14, PHS AP World History students, under guidance from teacher Holly Cregar-Porch, participated in the Third Annual AP World History International Kahoot! Battle, an online competition that helps students prepare for their AP US History exam. Fifty freshman gathered in F100 and using district laptops and

green screens competed with over 6,800 participants. The competition was so intense they broke Kahoot! after twelve questions and completed the Kahoot! verbally. The students enjoyed the experience that helped prepare them for their exam on May 17.

KING TEACHER APPRECIATION

King fourth graders in Rooms 30 and 31 appreciate their educators. Teachers Mrs. Paust and Mrs. Hutchinson encouraged their students to identify teachers, administrators and support specialists who helped and inspired them throughout the year. Students showed their thanks by writing detailed reasons for their appreciation. The students then used their artistic talents to create portraits of these influential educators.

MS FITNESS CHALLENGE

More than 120 students from all three middle schools competed in the Middle School Fitness Challenge. The PE staff did an amazing job adapting events to the PHS Anthony Gym after unexpected rain. Cash receipts, other than from Sales of National Lunch Program and School Breakfast Program meals and After School Snack Program meals served to the children, shall be divided by \$3.00 to arrive at an equivalent meal count. The per meal management fee of \$0.2906 will be multiplied by total meals.

Sodexo guarantees that District shall receive an annual financial return of One Hundred and Fifty Thousand Dollars (\$150,000.00) for the 2018-2019 school year. If the annual financial return for the Food Service program falls short of the aforementioned amount, Sodexo shall pay the difference to District. Sodexo reserves the right to recover any such reimbursement made during the current contract year from that year's Surplus on a monthly basis. - The state or federal minimum wage rate and taxes in effect as of July 1, 2018, shall remain consistent throughout the year
- Average daily attendance ("ada") and the number of free and reduced price participants shall remain at the same levels as the previous year.
- There shall be no competitive sales during all service hours.
- Due to the volatile nature of raw material costs, Sodexo and School Food Authority shall review quarterly, costs associated with paper and plastic supplies and fuel surcharges on other deliveries. Any significant or substantial changes in Sodexo's costs may result in a mutually agreed upon change in the guarantee reflecting the additional costs.
- Special Functions Sales shall remain at or exceed the levels of the previous year.
- Ala Carte sales shall be permitted at all locations for the term of the contract.
- Sodexo shall commence all vending operations and ala carte and snack programs on the first day of the school year and shall continue said operations until the last day of the school year.

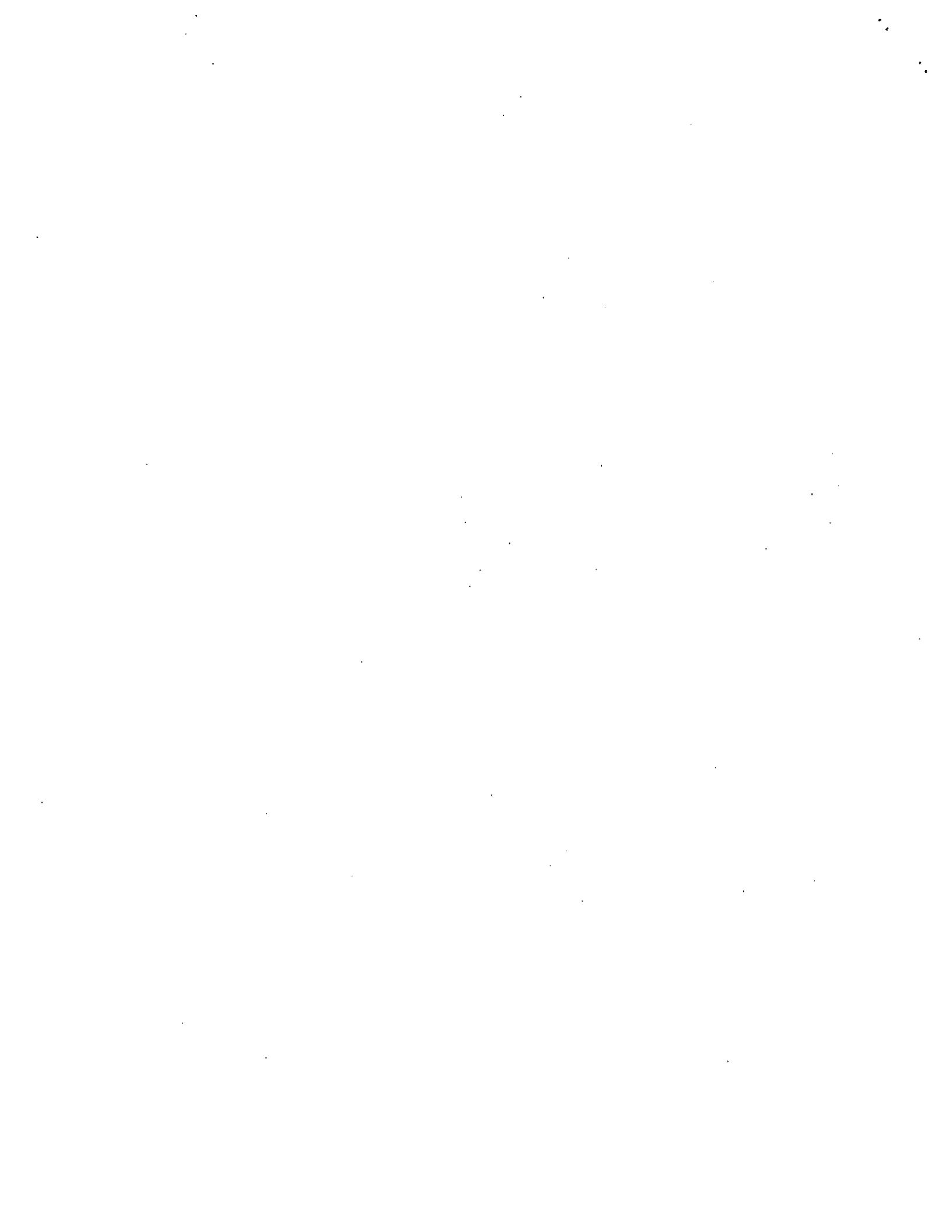

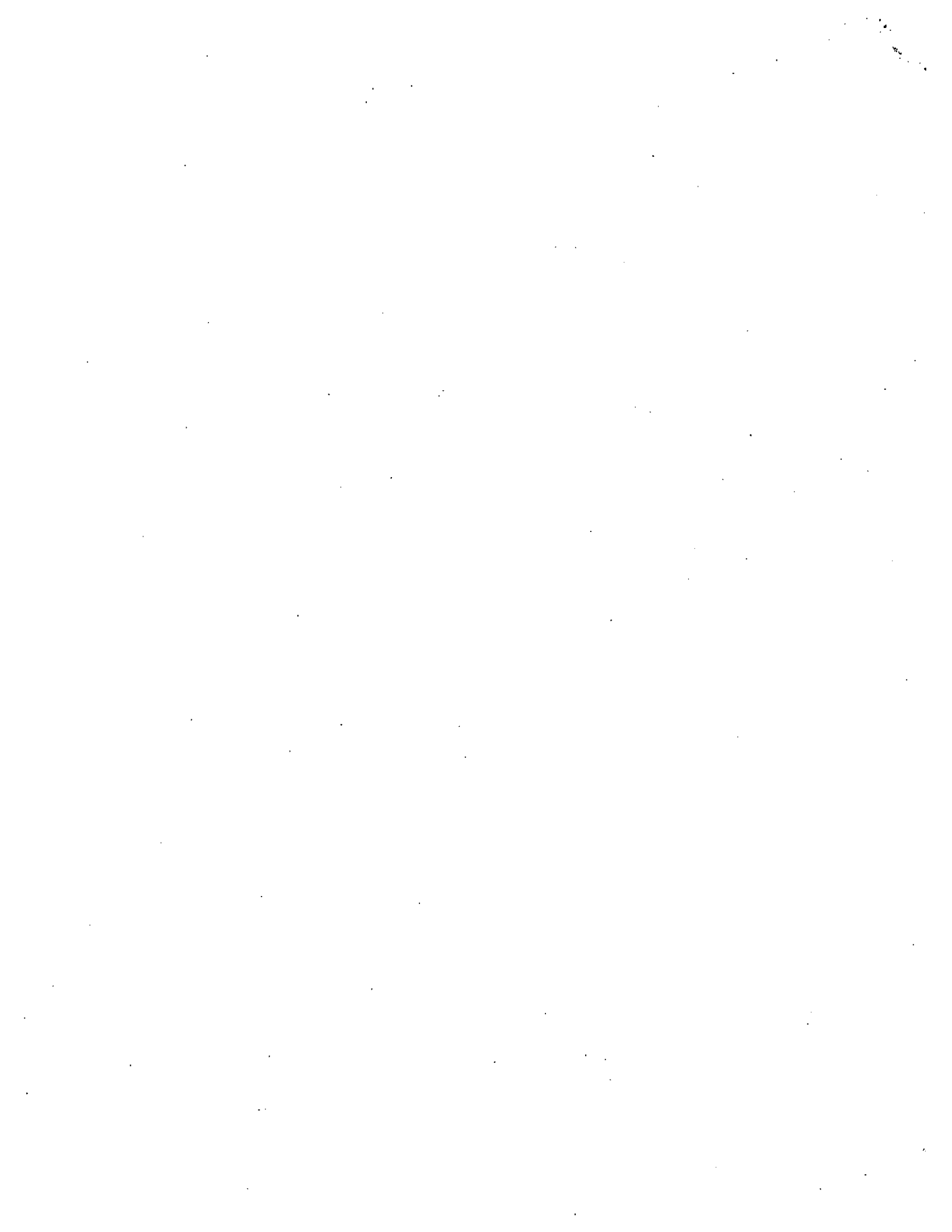

WHEREAS Piscataway Township School District ("Board") desires to transport special education, public and vocational school students to specific destinations; and

WHEREAS, the Somerset County Educational Services Commission ("SCESC") offers coordinated transportation services; and

WHEREAS, the SCESC will organize, provide and schedule routes to achieve the maximum cost effectiveness;

NOW THEREFORE, it is agreed the Board will pay prorated contract costs, plus an administration fee of 4%, as presented to the Board as calculated by the billing formula adopted by the SCESC. The total amount to be charged to the Board will be adjusted based on actual costs. Payments will be due within 30 days of receipt by the district and deemed late after 60 days with an additional 1% fee for late payments. At the discretion of the SCESC, late fee charges may be waived for extenuating circumstances.

- 1) The SCESC will provide the following services:
 - a) Routes coordinated with other districts when possible to achieve a maximum cost reduction while maintaining a realistic capacity and travel time;
 - b) Monthly billing and invoices;
 - c) Computer print-outs of student lists for all routes coordinated by SCESC;
 - d) All information necessary for the accurate submission of the District Report of Transported Resident Students;
 - e) All necessary interaction and communication between the sending district, receiving school, and the respective transportation contractors;
 - f) Constant/timely review and revision of routes;
 - g) Transportation as soon as possible after receipt of the formal written request;
 - h) Timely submission of contracts, contract renewals or contract addenda to the county office for approval.

- 2) It is further agreed that the Board will provide the SCESC with the following:
 - a) Copies of district policies as they relate to ride time or other specific transportation parameters;
 - b) Request for transportation on forms to be provided by the SCESC, completed in full and signed by authorized district personnel;
 - c) Forms will contain all necessary and relevant information, medical or otherwise, regarding individual student's condition and transportation needs;
 - d) Withdrawal from any transportation in writing, signed by authorized district personnel; and
 - e) Strict adherence to the established payment schedule.
- 3) **Additional Cost:** All additional costs generated by unique requests, including but not limited to, mid-day runs or early dismissals, will be borne by the district making such request.
- 4) It is understood that any change in the number of students being transported on each route, or changes in mileage during the course of the year will necessitate a reapportionment and adjustment of costs.
- 5) The SCESC accepts no responsibility for assuring a pupil's use of arranged transportation or attendance on an established route. Once assigned to a route, the monthly billings for the pupil's reserved seat will continue until the SCESC is otherwise notified, in writing, to delete the pupil from the assigned route.
- 6) The SCESC will contract transportation each day while school or classes attended are in session unless the Board's district is closed due to weather conditions (snow, ice, flooding, etc.). The SCESC accepts no responsibility for defaults by transportation contractors; however, the SCESC will make every effort to re-establish transportation expeditiously.
- 7) **Other Services:** The SCESC also provides coordinated regional bus maintenance services, safety training, and other related transportation services for an additional fee as a shared services program, the Board may participate at any time.
